9 f) Intermunicipal Collaboration Framework Agreement

One of the new requirements of the Modernized Municipal Government Act (MMGA) is that municipalities must have an Intermunicipal Collaborative Framework Agreement (ICF) in place. This new agreement would replace the Memorandum of Agreement (MOA). Council was presented with a new Agreement which has been reviewed and approved by the ICF Committee.

Res. 153-17 MOTION: Moved by Councillor Reid that Council approve the Intermunicipal Collaborative Framework Agreement between Mountain View County and the Village of Cremona as presented which will come into full effect January 1, 2018.


Mayor Hagen gave an update on upcoming events in the community:
