Council Meeting Highlights — March 21, 2017

Appointment of Returning Officer for 2017 Municipal Election

Section 13(1) of the Local Authorities Election Act RSA 2000 Chapter L-21 states:

13(1) An elected authority may, by resolution, appoint a returning officer for the purposes of conducting elections under this Act.

(2) If the elected authority does not appoint a returning officer, the secretary is deemed to have been appointed as the returning officer.
(3) The returning officer for a local jurisdiction may not be a candidate for the elected authority for that local jurisdiction.

Council appointed Luana Smith as the Village of Cremona Returning Officer for the 2017 Municipal Election.

Cremona Ag Society Request for Funding

At the budget meeting on February 13, 2017, Jamie Veres made a request to Council to provide funding to help with the expansion and improvements on the arena. .
Council approved to donate \$3500 per year for 2017, 2018 and 2019 to the Cremona AG Society for arena renovations with funds coming from the Council Community Grants and Enhancement budget.

Date of Special Council Meeting
