Council Highlights May 19, 2015

ATCO GAS & PIPELINE LTD. (ATCO)

Doug Brown and Gordon Stangowitz attended the Council meeting to give a presentation on the renewal of the Franchise Agreement with ATCO. In order to renew this agreement, a bylaw to authorize and execute an agreement with ATCO to confer a franchise on the company to delivery natural gas to customers within the Village of Cremona is required. Council gave first reading to Bylaw 460-15. Advertising will take place for members of the public to comment and it will then go to the Alberta Utilities Board for approval. This is a 10 year agreement.

PUBLIC HEARING

A public hearing regarding Bylaw 459 -15 to amend Land Use Bylaw 395-06 to change the zoning for Plan 0913234, Block D, Lot 2 from Urban Reserve (UR) to General Residential (R2) took place. Following the Public Hearing, after hearing from members of the public Council gave second and third and finally passed reading of Re-zoning Bylaw 459-15.
